- 3. Email a **LEGIBLE HIGH QUALITY PDF** copy of all documents to <u>aypapps@cisscanada.com</u> (JPG or other image files are often NOT accepted by school boards. PDF only please).
- 4. Application Fee (\$500 CAD) is due at time of application submission and is non-refundable for any reason of withdrawal
- 5 Payment: Programme payment must be arranged per the CISS MLI payment plan prior to issuance of legal documents (Letter of Acceptance and/or notarized Custodial Declaration).
- 6. Study Permit: All international students applying for a study programme with a duration of 6 months or longer are required to obtain a Study Permit from the Canadian Customs and Immigration Department at the Canadian Embassy assigned to their country/region. (www.cic.gc.ca)
- 7. ETA (Electronic Travel Authorization) is required for visitors who do not need an Entry Visa (TRV).
- 8. Students attending a study programme in the province of Québec are required to also obtain a CAQ (Certificate d'acceptation du Québec) in addition to a Canadian Study Permit. CISS MLI staff will provide most up-to-date applicaiton version once we receive the student's application for a school in Quebec.
