CONDITIONS

GREEN TRAVEL REQUEST FORM

Travel in the Green category will be approved by CISS MLI or MLI Homestay and may include overnight trips with Host Family (including unique trips, or regular visits to a family cottage or relative's home), trips with the school, with CISS MLI, MLI Homestay, or trips arranged by a sport or social club. School or club trips require waivers specific to that organization which our team or the host family will sign.

Note: Any trip that have a travel cost greater than \$500 CAD will be moved to the ORANGE level, and will require Natural Parental Permission.

YELLOW TRAVEL REQUEST FORM

Conditions for travel On Own/With Friends, Out of Community

Students MUST adhere to the following travel conditions.

Failure to abide will result in this privilege being revoked by MLI Homestay

- Must travel on public transportation that is frequent and reliable
- May NOT travel in car driven by person under age of 25, or in a taxi/uber/Lyft etc
- Must communicate plan clearly with host family and Local Coordionator including where going, with whom
- Bus/train number + To and From
- To include time of departure and time of arrival back home
- To include full name (first and last name) and phone number of friends who are travelling with them
- Must be back at host family home by 20:00 (or receive PRIOR Local Coordinator and Host Family permission if event will be later)
- Must plan travel well NOT wait for last bus/train back
- May NOT miss school

Specific to British Columbia - students taking a ferry between Vancouver and Victoria (or other Icoation on Vancouver Island) must submit TRF and obtain approval prior to travel.

Conditions for With Friends, In Community, Sleepover

Requests for a SLEEPOVER must meet the following criteria to be approved. Host Family for the overnight is:

- An approved MLI Homestay family (ie. Friend is another MLI Homestay student)
- An approved host family from another reputable Homestay Company (ie. Friend is international student from different organization)
- A local family who has agreed to host (ie. Friend is a local Canadian)

ORANGE TRAVEL REQUEST FORM

Day Trip: For any student living in a city that borders the USA (ie. Windsor, Thunder Bay, Vancouver) in which the host family regularly travels to the USA for shopping, entertainment etc, a separate waiver may be arranged to allow for a more open permission to allow cross-border travel by the host family and/or the school.

For travel with natural family friends or relatives: upon first request, a separate general waiver will be provided for natural parents to authorize visitation with this family friend/relative. Subsequent requests for visitation for same family friend/relative will be considered GREEN and authorized by CISS MLI or MLI HOMESTAY Head office.

BLUE TRAVEL REQUEST FORM

Specifically for students in Ontario communities bordering Quebec in select school boards only. Travel must be with accompanying adult (25 yrs+) such as host family or school trip.

Only for students in Catholic District School Board of Eastern Ontario, Upper Canada District School Board, Ottawa Catholic District School Board, and Ottawa Carleton School Board in Ontario

TRAVEL NOT PERMITTED

- ON OWN trips overnight out-of-community, out-of-province or out-of-Canada are never permitted
- Trips with minor-aged friends, overnight out-of-community or any travel with minor-aged friends out-of-province or out-of-Canada





NOTE:

It is the student's responsibility to monitor the timelines for submitting travel plans, to allow CISS MLI or MLI Homestay to arrange the required permissions. Last minute travel requests may not be accepted.
