This agreement is for any student applying for the CISS MLI High School Programme who will be 18 years old for the duration/majority duration of their programme

For the student...

In signing this agreement, I understand and acknowledge that this high school programme is designed for students who are **14-17** years of age, and that ALL STUDENTS are under the custodianship and authority of CISS MLI, their school and their host family.

I understand and agree:

1. Although I will be older than 17 years of age at the time of my programme, I fully accept and agree to follow all aspects of the **Student Code of Conduct and Programme Terms and Conditions**, signed as part of my application. I will abide by the rules and regulations set out by CISS MLI, the school and my host family including behavioural expectations and rules regarding curfew, communication, internet usage, schoolwork and assignments.
2. I understand that although I will be legally considered an adult, I will always recognize that CISS MLI is my custodian, and I will respect their authority as a participant in this programme.
3. I will attend all my assigned classes, complete all required homework and take all scheduled tests and exams during my programme duration. I understand that I may not skip classes except for reasons of illness or other legitimate reasons.
4. Although I may be of legal age to purchase cigarettes/e-liquid in select locations, I understand and agree that smoking/vaping is not permitted in or around my school and may not be permitted in my host family home. I agree to refrain from smoking/vaping while on the programme and will not purchase cigarettes/e-liquid for someone who is underage.
5. I agree that if I visit Alberta or Quebec where the legal alcohol drinking age is 18, I will not purchase alcohol for myself or for any other underage person, nor consume any alcoholic beverages or enter a bar, pub or nightclub where the minimum age of entry is 18. I will also follow the standard agreement that anywhere else in Canada, the legal drinking age is 19, so NO STUDENT is permitted to purchase or consume alcohol or attempt to enter a bar, pub or nightclub where the minimum age of entry is 19.
6. I understand that laws regulating the personal use of cannabis are restricted and will follow the same age guidelines as for alcohol. I agree that the restrictions above in point #5 are also in effect for purchase/consumption of cannabis or cannabis products.
7. I agree that even if I hold a valid driver's license from my home country, I will not drive or operate a motorized vehicle in Canada.
8. I understand, however, that should I commit a criminal offense, police and courts will try me and may convict me as an adult, not a juvenile.

Any disregard for this agreement may result in my termination from the programme.
